The Town Council of the Town of Sussex met in special session, by appointment of the Mayor of the said Town, in the Council Chambers of the said Town on Wednesday the 3<sup>rd</sup> day of May, 2006, at 7:00 o'clock in the evening.

The following members of the Council were present: His Worship Mayor Carr, Deputy Mayor Thorne, Councillors Fulton, Wright, Wilson and Black. Councillor Bradley was absent. Also present at this meeting was the Town Clerk/Treasurer, Paul Maguire.

It was moved by Councillor Black, seconded by Councillor Fulton, that the agenda for this special Town Council meeting be approved. Motion carried.

Councillor Black declared a conflict of interest on Item # 4 New Business: Mural Project and vacated the Council Chambers for any discussion or decision on the item. Councillor Black did not return to the Council Chambers from his conflict of interest.

The Chairperson of the Administration Committee brought forward to Council the request of the Kings East Development Partnership Inc. that the Town approve the painting of murals on eleven sites in the downtown during the summer of 2006. The Kings East Development Partnership Inc. had submitted the required applications to the Planning Advisory Committee and the Administration Committee. It was noted that all the murals have a historical reference to the Town of Sussex and that the painters of the murals will be world class mural artists and that a competition

was held by the Kings East Development Partnership Inc. to choose the murals and the artists.

It was moved by Councillor Wilson, seconded by Councillor Wright, that Council approve the following murals as submitted by the Kings East Development Partnership Inc.:

- ◆ 12 Maple Avenue;
- ◆ 489 Main Street;
- ◆ 35 Broad Street;
- ◆ 551 Main Street;
- ◆ 12 Church Avenue;
- ◆ 581 Main Street;
- ◆ 635 Main Street;
- ◆ 46 Magnolia Avenue;
- ◆ 620 Main Street; and
- ◆ 614 Main Street.

Motion carried.

The Chairperson of the Administration Committee informed Council that the Kings East Development Partnership Inc. has requested permission to place a mural on the building at 12 Maple Avenue which is owned by the Town of Sussex.

It was moved by Councillor Wilson, seconded by Councillor Wright, that the Town of Sussex permit that a mural be painted on the building owned by the Town at 12 Maple Avenue as submitted by the Kings East Development Partnership Inc. and that the Council authorize the Mayor and Town Clerk to sign the Sussex Mural Project Locations Agreement on behalf of the Town. Motion carried.
