The Town Council of the Town of Sussex met in special session, by appointment of the Mayor of the said Town, in the Council Chambers of the said Town on Monday the 1<sup>st</sup> day of November, 2010, at 6:30 o'clock in the evening.

Mr. Corbett gave a brief review of each Section of the proposed plan and the input that was received from the public as well as the Committee members. Members of the Council had an opportunity to ask questions of Mr. Corbett on the public presentation.

It was moved by Councillor Bradley, seconded by Councillor Wilson, that Council set December 8, 2010, at 6:00pm in the Council Chambers of the Town of Sussex as the date, time and place to hear objections to the Municipal Plan, By-Law # 704-10, and the Zoning By-Law, By-Law # 1350-10. Motion carried.

His Worship Mayor Carr noted that there is a special Council meeting scheduled for Tuesday, November 2, 2010, at 5:30pm in the Council Chambers of the Town of Sussex and on the agenda will be the Christmas Tree Lights, River Front Development Plan and the Community Services Officer.
