It was moved by Councillor Ryan, seconded by Deputy Mayor Carr, that Council sponsor a hole in the PCS 2015 Golf Tournament in the amount of \$200.00. Motion carried.

It was moved by Councillor Ryan, seconded by Councillor Milner, that Council award the RFP for the traffic study to WSP for a fee proposal of \$22,697.40, HST included. Motion carried.

It was moved by Councillor Ryan, seconded by Councillor Milner, that Council approve that the Town Clerk/Treasurer be authorized to issue two cheques to the Covered Bridge Visitor Information Centre for the budgeted amounts of \$5,000.00 as a grant towards their 2015 operating costs, and a second cheque for \$1,500.00, plus HST, for the Town of Sussex Enhanced Membership Plan for 2015. Motion carried.

Councillor Milner informed Council of the success that the local ATV Club has had in bringing ATV tourism to the Town, and noting that some of the users of the ATV trails are staying at local motels.

Councillor Milner also noted that Tourism New Brunswick is going to highlight the ATV trail system in the Sussex & Area in their promotional material.

Councillor Ryan spoke on the importance of partnerships that the Town of Sussex is engaged in, in particular the partnership with CN and the Kings County Watershed Committee involved in planting seedlings, and also the partnership with the Sussex Middle School which recently planted 1,200 Magnolia plants on Maple Avenue.

Councillor Armitage, on behalf of the Council, wished the recent Graduates Congratulations on their accomplishments and encouraged the Graduates to have a safe and enjoyable Graduation week.

His Worship Mayor Thorne brought to Council the concerns of citizens regarding the tourism sign located at the top of Prescott Hill.

The Mayor noted that the sign was erected by the Sussex Chamber of Commerce, not the Town of Sussex, and that originally the sign was on DOT lands but recently these lands have changed hands and are now privately owned. Mayor Thorne informed Council that he intends to try to resolve the issue of the tourism sign by initiating a dialog between the solicitor who presently represents the land owner and the Sussex Chamber of Commerce to hopefully have the two parties agree on the maintenance of the sign.

His Worship Mayor Thorne informed Council that the CAO and himself had met with the Minister of Public Safety, Minister Horsman, regarding the closure of the Sussex Court House. The Minister informed the Mayor that the Court House was not presently meeting the requirements regarding the safety segregation of the cells of the accused, washroom facilities and other standards, and that due to the costs of meeting these standards and upgrading the facilities the Court House will be closed as previously announced. The Minister did however inform the Mayor that the Town will be receiving information regarding the closure of the Court House and the standards that could not be met at the facility.
