The CAO informed the Council that a Public Tender was opened on Monday, June 22, 2015 at 2:00pm. Two contractors submitted acceptable pricing as follows:

EJ Cunningham Ltd.	\$179,503.33
Sussex Excavators (2010) Ltd.	\$188,246.70
Engineers Estimate	\$166,220.18

The scope of the work includes reconstruction of approximately 150 lineal meters of existing road surface, installation of concrete curb and gutter on both sides of the street and installation of a new concrete sidewalk on the Phase 3 portion of the street works. This project also includes placement of asphalt seal on the entire length of Lansdowne Avenue south. This project will complete the reconstruction of Lansdowne Avenue South which began in 2013. The contract amount includes a contingency allowance of \$10,000.00. The project is within anticipated budget for this 2015 capital project.

It was moved by Councillor Wilson, seconded by Councillor Ryan, that Council award the subject tender to the Low Tenderer EJ Cunningham Ltd. in the amount of \$179,503.33, inclusive of HST. Motion carried.
